### Project Description

- *Demolition:*
  - Removal and disposal of existing seawall; approx. 3,668 LF
  - Removal and disposal of collapsed materials from nearshore shelf
- *Site Work:*
  - Excavation and fine grading of existing bank to support shoreline stabilization; approx. 3,217 CY
- *Installation:*
  - Furnish and install rock revetment; approx. 8,827 TN
  - Furnish and install marine mattress with geotextile underlay; approx. 93,558 SF
  - Furnish and install rock apron; approx. 431 TN
  - Furnish and install geotextile fabric; approx. 13,492 SF (exclusive of geotextile fabric affixed to marine mattresses)
- *Site Restoration:*
  - Clean-up and dispose of any/all construction debris, equipment, material, etc.

*The bid also includes a Bid Alternate to fill in the gaps of the proposed shoreline stabilization at the existing private docks. The quantities are included below.*

### Bidder's Representations

- Bidder has examined and carefully studied, in detail, the Construction Drawings, Project General Notes on Sheet CM-1.1, other related data identified in the Plans, and any subsequent addenda to this bid request.
- Bidder has visited the Project site and become familiar with and is satisfied as to the general, local, site, and structure conditions that may affect cost, progress, and performance of the Work.

- The Plans are generally sufficient to indicate and convey understanding of all terms and conditions for the performance of the Work for which this Bid is submitted.

## Project Limitations

- Parking & Access:
  - Parking, equipment and material staging, and access to the site to be coordinated with the Board prior to construction. Contractor shall base his bid assuming all work shall be done from a barge. Upland access between houses is not authorized.
- Hours of Operation:
  - No work shall be conducted on weekends (Saturdays or Sundays)
  - No work shall be conducted during the hours of 5:00 p.m. through 8:00 a.m.
